Contract & Application**

Vendor Application for show taking place on June 13th & 14th, 2008

I/We, the Vendor, in signing this contract, agree to abide by the "Rules and Conditions of the Show" which are part of this agreement. Vendors agree to these terms for each show attended as a Vendor from this date forward until further notice.

RULES AND CONDITIONS OF THE SHOW:

1. The Vendor hereby expressly releases the promoters, Foundation LLC, of any and all liability for damage, injury or loss of any person or goods from any cause whatsoever and further agrees to indemnify the promoters against any and all claims for damage, injury or loss arising out of or in connection with the use of the space of grounds of this show or the display and/or sale of any merchandise by him/her.
2. No display is to be attached to any of the walls or columns with out venue approval.
3. Booth rental is \$45.00 per 10' x 10' space.
4. Booth rental fee is due paid in full in order to secure space at the show date listed above.
5. No pets are allowed at the West Bottoms Urban Bazaar.
6. Vendors are responsible for clean-up of their booth. Abandoned merchandise will not be accepted. Vendors MUST take all merchandise with them upon end of the show. Vendors who do not clean up or take all their merchandise with them will not be invited back to the West Bottoms Urban Bazaar.
7. All Vendors will be responsible for collecting and paying sales tax applicable in the state of Missouri.
8. Foundation LLC assumes no responsibility for any damages when providing help at time of load in or load out
9. CANCELLATIONS – Foundation LLC may cancel this contract at any time with written notice to the Vendor. If Foundation LLC cancels this contract, the Vendor's booth rental shall be returned and the Vendor waives the right to damage beyond the return of the booth rental fee. In the case that the Vendor cancels, Foundation LLC is not liable to return any booth rental fees and the Vendor waives the right to damage beyond the return of the booth rental fee. If Vendor cancels within 14 days prior to show date, payment will be applied to next available West Bottoms Urban Bazaar show date.
10. Friday set-up time: 9:00am to 6:00pm. Saturday set-up time: 8:30am to 10:00am. Foundation LLC encourages all Vendors to set-up early Friday and be ready to sell during the preview shopping party. Vendors are allowed to set-up Saturday morning during the allotted time. Saturday's event is from 10:00am to 3:00pm. Vendors who begin packing before 3:00pm will not be invited back to the West Bottoms Urban Bazaar
11. Vendors MUST be packed and out of the West Bottoms Urban Bazaar space by 5:00pm
